Me v. the CBC

Hey,

I must say that after the CBC had ignored me for years, I was not surprised that it had chosen to offend me as I threw my hat in the ring last week to run for Parliament. When I heard the other dudes debating on the radio Monday morning without the CBC extending me the opportunity to be included, I saw red. Last week when it reported that there was a fifth candidate but failed to mention my name, I just giggled. What self-respecting reporter would not find out and report whom that person was after becoming aware of the candidate? It was bad enough when CBC delayed listing me on its website but it just served to embarrass them for their lack of diligence in reporting the complete news of the election. However to ignore my call after I had registered my indignation for being excluded from the debate took the cake. What would a Liberal or a Conservative have done if the CBC had treated them in such a fashion? Why would I be different? Thus I opted to send this letter. I challenge the ethics of its Directors and lawyers. Perhaps they should check the work of the CBC before I file a complaint.

Within one hour of calling David Bazay of the Office of the Ombudsman to see if he is a lawyer, Dave Young, a reporter at the local CBC office, called me to claim that he had just become aware of my existence. He attempted to argue with me while denying that my call to the Ombudsman had prompted his call. Mr. Bazay seemingly chuckling at the notion of a man suing the CBC and only served to make me angrier. In deed (his words) we shall see who laughs last. I cannot send him a copy of a wiretap tape because he is not a law enforcement officer or an officer of the court but I can certainly send him a summons. Dave Young's call to me only made matters worse.

Dave Young now wished to tell a story about me. We then discussed briefly the mandate of the CBC and who actually owned the corporation. I then backed away from him and declined the opportunity to be interviewed by him. I did not believe his first words to me nor did I trust his vague answers to my questions, therefore I could not trust him with my words. His hostility was apparent and far from a neutral stand point to report the news. Although both the aforesaid men named Dave are not lawyers this Dave has talked to enough lawyers to recognize when another layman has been briefed by lawyers in what to say and do. The last words anyone should trust as true are those that come byway of lawyers. If you don't believe me ask another Dave. His last name is Orchard. His complaint was dismissed for reasons beyond my understanding of the law.

In a Orchard long ago another man was well aware that his friend named Peter would lie a lot before the cock crowed. Bearing false witness against a friend is as old as man and one does not have to worship a god to be aware of that fact. I still recall a few Sunday School lessons even though I refused to be baptized. Mr. Orchard has learned the same lesson I have learned long after Sunday School was over for me. Never trust the word of a lawyer even if he puts it in writing acting as your attorney. It has been my experience that the same holds true for a newsman too. Mere mortal men man the mike of the media. They are as capable as any lawyer to delay or deny a man for lucre or malice. The newsmen do have the important freedom to report what they choose but CBC does have a mandate to at least present a complete unbiased view of political matters for the benefit of the public it serves. I am part of that public as well.

Whereas the Media cannot be trusted to report the whole truth of all matters, I prefer the old fashioned way of speaking directly in person to the people that actually cast the ballot. Many people within Fundy know me or know of me through a very few degrees of separation. I am comfortable that they can rely on their own opinions of me or that of their neighbors. Those opinions count to me. Either good, bad or indifferent it will be their personal judgement as to whether or not I am worthy of their vote in order to uphold the Public Trust and speak in their best interests. The opinions of reporters who are employed by large corporations hold no water to me.

If Dave Young wishes to write a story about me, he may glean what he wishes from the enclosed documents in order to come to an understanding of my character. Better yet perhaps he should listen to the debate on Friday that I wasn't invited to and was compelled to pay in order to attend. However only a cop or a lawyer should listen to the CD. I will not discuss my legal issues in the USA in a campaign to become the elected representative for Fundy. These issues are of no relevance to the concerns of the electors in Fundy. However the lawyers of CBC should study closely every word of every document that I have provided them. After reviewing this material maybe the CBC lawyers should find the documents that I sent to Sophia Harris and the US Ambassador Argeo P. Cellucci almost two years ago. Within those documents I clearly explained to all why a private man has been forced to become a political animal.

I am no more or less than what I have always claimed to be. I am a decent bike mechanic and a very proud father that assumed the role of a Mr. Mom. Like most other men from the Maritimes I am just a simple, sincere and serious man but I am more pigheaded individual freedom than most. To say that I am very argumentative in defending my civil rights would be a fair statement. I have enjoyed my life. I have never yearned to be a lawyer or seek a political office to speak for others. Whenever I stand before the bar as a layman in pursuit of a legitimate argument with many sneering lawyers in front of my peers, the evil bastards conspire and run for cover.

Now that I entered the political arena I was not surprised to see that the media maintained standard operating procedure for all the smiling bastards seeking four more years of political gain. However I am now on my home ground where many people know of me and of my actions. Let us all see who is ethical and who is not as I debate politicians about matters that concern Maritimers not lawyers. I understand how Maritimers think.
